Sen. Port currently serves on the Technology and Reform Committee, Commerce Committee, Housing Committee, and is the DFL lead on the Metro Governance Committee.

I recently attended the Minnesota History Theatre's "Not in our Neighborhood! A story of Courage, Faith and Love" show. It felt wonderful to be back in a theater seat surrounded by other history and theater lovers even with the difficult subjects tackled by the show. I'll start with the good news – Nellie and William Francis, the black couple who had the audacity to move out of their St. Paul Rondo neighborhood to the all-white Macalester-Groveland neighborhood in 1924. Nellie and William were a power couple before we coined the term. Wikipedia them – their list of accomplishments is too long for this space! They accomplished the mission but not without cross burnings, angry mobs, threats and disingenuous politicians. Skip forward to today and the recent headlines that the Twin Cities has the nation's highest racial gap for homeowners. One in five black household owns their homes compared to three quarters of white households. I encourage you to read the host of articles that go into depth on the reasons why. While we have failed so far to live up to Nellie and William who took the brave step, risking their safety and sense of security, to dare to hope for a better tomorrow we can be the change. Acknowledging and understanding the reasons for the disparities are a start.

Back to home, leaders in our town are participating in a learning opportunity sponsored by THRIVE and the Y Equity Innovation Center titled "Creating a Better Story." The sessions explore diversity, equity and inclusion in the formation of our community, the 170 plus years to today, and the hope and vision for the future. Writing this today, I understand that many may question where the "Better Story" is heading with fresh divisions and heated rhetoric, but it is still in our hands how we create that better story and live up to the bravery and extraordinary examples of Nellie and William.

AAUW Business Meeting October 25, 2021 St Philips Lutheran (In-Person and Zoom stream)

1. President Lisa Hedin called the meeting to order at 7:00 pm.

The President's Greeting included the following announcements:

- (a) A reminder to vote in the November 2nd District 200 School Board Election. Interviews with all six candidates were published by the *Hastings Journal and the Hastings Star Gazette* (online only) and can be viewed online. The Chamber of Commerce/HCTV candidate Forum video is also online. Early voting can be done at the Dakota County Government Center and the District 200 Office, currently located in the Hastings Middle School.
- (b) Our branch is seeking a webmaster, i.e., a website apprentice, a website assistant. Any member willing to learn and spend some time updating and maintaining the branch's website should contact Lisa.

- (c) After the 50th Anniversary Celebration event at the Hastings Public House, a ring was found. Contact Nicole Sindelair at the Public House if you lost one that evening.
- (d) The minutes of the May 24, 2021 Business Meeting, as published in the September *TWIG*, were approved. Motion: Pat Powers; Second: Kathy O'Keefe.
- 2. Carol Tobin, Treasurer, reported an September 30, 2021, balance of \$7,553.94, plus a deposit of \$103 for late membership dues, minus expenses paid of \$2,575.33, resulting in a current balance of \$5,081.61. The Treasurer's Report was approved. Motion: Danna Elling-Schultz; Second: Betty Hoeschen.

3. Committee Reports

- (a) Membership: Kathy Palmer reported on a total of 85 members for 2021-22. Four new/returning members joined at the 50th Anniversary Gala, resulting in two Shape the Future membership discount awards from AAUW National to our branch. The final draft of the 2021-222 AAUW Hastings Branch Membership Directory will be emailed to members in December or January.
- (b) Programs: Danna Elling-Schultz announced the traditional annual bookmark listing the program speakers for the year has been printed and is now available for distribution.
- i. The November program will be "Paid Family & Medical Leave Legislation & Pay Equity Initiatives" by State Senators Susan Kent & Lindsey Port. There will be no traditional chili supper in January due to Covid. ii. The Holiday Brunch will be on December 4, 10:30 am, Hastings Public House. Members may bring a guest, and there will be a drawing. No fundraising will be done.
- (c) Fundraising: Ceil Strauss reported on the very successful fundraising activities to date: The Hastings Rivertown Days booksale raised approximately \$500 (net). Ninety-five members and guests attended the Wine Soiree at the Public House. About \$2,500 was raised (net).
- (d) Public Policy: Pat Powers reminded members of the importance of responding to the Two-Minute Activist emails from AAUW National.

Current: Pass the bill including paid parental leave and child care.

Pass the Paycheck Fairness Act.

Pass the bill to raise the Federal minimum wage. Pass legislation to end pregnancy discrimination in employment.

AAUW turns 140 years old this year. See the virtual celebration program on November 17.

- (e) Bookclub: Shirley Tammen noted the Bookclub will meet in the Pleasant Hill Library on November 8. The book to be discussed will be *Killers of the Flower Moon*. The book originally planned for November (*Firekeeper's Daughter*) will not be available as a bookclub bag until December.
- (f) AAUW Funds: Glenda Schnirring reported the 2021 scholarship award to Kaya Felt (University of North Carolina/Chapel Hill) has been made in a timely fashion, thanks to the successful fundraising this summer/fall. She reminded members that any donations made by our members to National AAUW causes will be credited to our branch's total annual AAUW support amount, in addition to our traditional branch donation of \$1,000.

- (i) Community: Margaret Goderstad reminded members of November events at the Hastings Art Center, the Orange Dragon Gallery in Prescott, and the River Valley Band Veterans Day Concert on November 7, 1 pm, at the Hastings Middle School.
- (j) Diversity: President Hedin urged members to take time to read Peggy Horsch's thoughtful articles on diversity published monthly in the TWIG.
